On January 23rd, 2016 Sheriff Troy J. Peterson announced the arrest of 32 year-old Pamela C. Guerrero who resides at 20943 LA-42 Prairieville, LA on a felony charge of Possession of Cocaine and Possession of Schedule II Narcotics.

On January 23, 2016 at approximately 10:55 PM, Deputy David Oliver conducted a traffic stop on a Dodge Charger driven by Guerrero on Interstate 10 at the 21 mile marker for a minor traffic violation. A subsequent search of the vehicle led to the discovery of illegal narcotics.

Guerrero was placed in custody without incident and transported to the Harrison County Adult Detention Facility where she is being held under a \$10,000 surety bond set by Justice Court Judge Dianne Ladner.
