On Friday, April 15th, 2016, at approximately 9:17 PM, Sheriff Troy Peterson announced the arrest of 33 year old, Donna J. Cole who resides at 23168 Enchanted Ave. Pass Christian, MS., on a felony warrant for Possession of a Controlled Substance and 37 year old Misty S. Hester who resides at 15080 Graff Dr. Saucier MS, on a felony warrant for Uttering Forgery.

On April 17, 2016 a Deputy with the Harrison County Sheriff's Department, conducted a traffic stop at F. Taylor Rd. near Blackwell Rd. on a 2007 Chrysler 300 for a Hazardous Moving Violation. The Deputy made contact with the vehicle operator identified as Misty S. Hester and a passenger in the vehicle identified as Donna J. Cole. A subsequent check of their identifying information revealed both subjects were wanted fugitives, Hester through the 1<sup>st</sup> Justice Court for Uttering Forgery and Cole through 1<sup>st</sup> Circuit Court for Possession of a Controlled Substance.
