Deputies made contact with the home owner who advised that Heather Connolly was in the bathroom of the residence. Shortly afterward, Deputies were able to make contact with Connolly in the bathroom.

Connolly was placed into custody without incident and transported to the Harrison County Adult Detention Facility where he is being held with no bond per the authority of Circuit Court Judge Bourgeois.
