**Tuition:** \$500 Per Student and (BJOST) will reimburse the student's agency up to \$720.00 plus a percentage of the student's salary while attending this training.

**Attendees:** Corrections Officers in need of State Certification

**\*Maximum Class Size is 20\***

**Class Description:** This course meets or exceeds Mississippi Minimum Standards (BJOST) training for full-time corrections officers.

**Topics Include:** History of Jails and Incarceration, CPR/1<sup>st</sup> AID, Health Care Issues, Legal Issues, PREA, Defensive Tactics, Jail Security, Stress Management, Use of Force, O.C., Duty to Intervene, Hostage Survival, Report Writing, Suicide Prevention, Inmate Con Games, Inmates with Special Needs, Excited Delirium and Inmate Supervision.

The Harrison County Adult Detention Center offers classes led by trained staff, including Warden Evan Hubbard. According to McArthur Center for Justice Foundation data, the center had the highest average inmate population among Mississippi's 84 County Jails from April 2018 to November 2023. Warden Hubbard has a career in corrections since 2005, including leadership roles and presidency of the Mississippi Jail Association. Lt. Paula Hentges, the lead corrections instructor, served in the U.S. Coast Guard and joined the Harrison County Sheriff's Office in 2004. She specializes in Corrections Training and is a 2011 graduate of the Harrison County Law Enforcement Training Academy.
